The current categories of Company Membership are as follows:

1. **Full Members**

Individuals, firms or companies whose turnover (as defined by the Council of the Company) within the marine industry is at least 51% of their total trading activities or whose turnover within the marine industry is less than 51% but exceeds Rupees 10,00,000 (One Million) per annum and who have completed a two year period of continuous trading within the marine industry. In exceptional cases membership may also be offered outside these defined limits with at least 75% of the Council members present and eligible voting in favour.

2. **Associate Members**

Individuals, firms or companies whose activities or turnover do not come within the definition of full members and who are considered by the Council of the Company to be eligible for membership.

3. **Affiliate members**

At the discretion of the Council any organizations whether associations or Company and whether or not connected with the marine industry which have a common interest and share the aims and objects of the Company.
